Notes To The Agenda

- 1. **Legal Structure**: South Hampstead Club Limited (Company Number: 00677843; Registered office: Ground Floor, Marlborough House, 298 Regents Park Road, London, N3 2SZ) is a company limited by guarantee incorporated on 14 December 1960. The Cricket Section and Tennis Section are sections of the Company.
- 2. **Voting Rights**: All fully paid-up adult Members of the Company are entitled to vote at this AGM. Any questions regarding eligibility to vote should be directed toward Ed Hewens.
- 3. **Quorum**: The quorum for the meeting is 20 Members personally present.
- 4. **Current Board Position**: Under the current 1960 Articles of Association (**1960 Articles**), Bob Peach is the sole remaining director of the Company. Bob Peach is standing for re-election and the slate of the other11 directors proposed in Ordinary Resolution 2 has been nominated and recommended by the current board (Bob Peach)

in accordance with the 1960 Articles after consideration of submissions from the committees of the tennis and cricket sections.

- 5. **Important Legal Requirement**: Items relating to Director elections and adoption of new Articles must be conducted in the order shown for legal compliance under the 1960 Articles. The 1960 Articles specify a maximum of 10 directors, but they permit the members at a general meeting to increase this maximum number. This increase has to be approved before the board proposed within Ordinary Resolution 2 is elected.
- 6. **Director Biographies**: Brief biographies of all nominated Directors are attached to this notice.
- 7. **New Articles**: If the new Articles proposed in paragraph 6 are approved as a special resolution, they will take immediate effect. A special resolution requires a 75% majority vote (of those attending the AGM and entitled to vote).

Ed Hewens - Edward Hewens joined South Hampstead Cricket Club in the summer of 2005 and played 1st and 2nd XI Cricket for around 8 years. He held the post of Interim Chair of SHCC in 2011 following the death of Brian Fuller until the 2012 AGM. From 2012 – 2015 he was Secretary of SHCC as well as leading various maintenance projects. Since 2015 Ed has held the post of Company Secretary at South Hampstead Club Ltd. When not writing minutes, Chairing the SHCC Disciplinary Committee, replacing fences or fixing drains at Milverton Road, Ed manages a residential property portfolio in West and South West London. He lives in Notting Dale, has two daughters who are indifferent to cricket and tennis, but a wife and dog who are very supportive of his sporting activities.

Mark Ducker - I trained as a Certified Accountant and have worked for the big 6 accountancy firms and Stock Market listed companies during a 30 year career. I have been a director of several companies in the past and have been a member at the South Hampstead Club on and off, since the early 1970's.

I am a lifelong resident of Kensal Rise and surrounding areas. I myself attended 'The Convent of Jesus and Mary' and 'St Mary Magdalenes' schools in Willesden, my children went to Malorees and QPCS and my partner works at Salusbury Junior School. I come from a sporting family and I am a strong proponent of participation in sport at all levels of ability. Having seen our club take a pupil from Malorees Junior School and for him to later face Roger Federer on the Centre Court at Wimbledon proves what is possible if this club works well together.

Daniel Seaman - Daniel has been a resident of the area since 2012 and has been involved in the administration of amateur sports since 2019 when he became junior manager for SHCC (although he has played far more tennis in his life than cricket!). Daniel is a current director of two companies: The Eye Rettery Company Ltd, a company responsible for the preservation and enhancement of 4.5 acres of community land in Suffolk and AndGrow.IO Ltd, a consultancy business. Daniel is CTO of a commodity data provider and has previously been responsible for managing the global budgeting process for a \$250m international business. Daniel has been on the SHCC committee since 2019 as Chair of the Junior Section and has grown the number of Juniors from 80 to 250 and managed the associated changes to the junior programme. He has led the development of an active Junior Committee through regular meetings and a team of age group Team Managers. Daniel has contributed hugely to the SHCC committee through meeting management, taking a lead on legal issues and pushing digitalisation.
